- New Mask Mandate

- Brooklyn Center - Still figuring things out
- Oakdale – Lifted masks guidelines, no official email yet for facilities. Programs and camps still TBD.
- Prior Lake - Masks lifted for facilities and outdoor programs
- Question – Will you put signs up regarding new policy?
 - New Brighton – Not lifted yet until official word comes from Governor and City. Yes signage will go up and based on what MN governor says and what marketing department says
 - Shoreview – Masks lifted, took down signs, and no signs will go up. Preschool program will encourage masks to be worn
